The Session met on Monday July 27 and approved the COVID-19 Preparedness and Response Plan for our church. This plan is being administered by Rev. Amanda Mackey and Amanda Frodermann, Parish Nurse.

A copy of this plan will be sent out via email and postal mail to all non-email church members. The plan lays out the phases for re-entering the church property including indoor and outdoor worship. Phase 3 is outdoor worship.

We have tentatively scheduled an outdoor worship service on Sunday September 20 if the COVID-19 cases in our area have decreased. The rain date will be on Sunday September 27.

If we have to cancel the service we will use all forms of communication to let the congregation know. The worship services will continue to remain on Facebook and on the DVDs.

**John H. Schwen**, 76, of Kasson, Minnesota passed away on July 22, 2020 at his home surrounded by his loving family.

He was born to parents Russell and Verlie Schwen on October 12, 1943 in Blue Earth, Minnesota. John graduated from Albert Lea High School and received degrees in English and Music from Mankato State University in 1967, where he was a member of the Phi Mu Alpha Sinfonia Fraternity.

John's passions were music and teaching. He directed band, taught general music and gave music lessons to countless students over his 32 year career. After retiring from teaching in 2000, he contin-



ued to play in the Notochords of Rochester.

In addition to music, John was known for his love of the game of golf, which he played until just recently. He also enjoyed watching the Minnesota Twins, Vikings and Gophers. He was an avid reader, movie buff, muscle car enthusiast, skilled woodworker and gardener.

While John's achievements and talents were numerous, he was humble and is best remembered for his kindness, generosity and dedication to his family and friends as well as his endless gift of music to all.

Now for something fun, here is a recipe from Paulette's mom. It is really easy, simple, and does not need to be baked which will save heating up the kitchen.

#### LEMON CHEESECAKE

1-2 oz. lemon jello 2 tsp. vanilla 1-8 oz. package cream cheese

1 - 13 oz. carnation evaporated milk (very cold) 1 cup sugar

Dissolve jello in 1 cup boiling water, let stand at room temperature. Mix the cream cheese, sugar and vanilla until creamy, set aside. Whip milk in a large mixing bowl until it looks like whipped cream, beat in the jello and then the cheese mixture.

CRUST: 1/2 cup sugar 20 graham crackers crushed to fine crumbs 1/4 cup melted butter

Mix all together well and press into a 9 x 13 pan saving some for topping or chopped nuts may be used instead. Pour cream cheese/jello mixture on top and chill for several hours. ENJOY!


